# 713fm Online Radio Terms & Conditions

## Description of Service, Acceptance of Terms, Modification

713FM ("713FM Online Radio"), provides the artists aka users ("Users") of the web pages located at www.713fm.org, and their associated subdomains including but not limited to www.713fm.org (the "Site") with a platform for the discovery, promotion of music, the sharing of information and comments about their music, communication with other artists, the posting, syndication of, linking to or uploading of User Content (defined below), social networking and other features, functions, or services on the Site (collectively, the "Service" or "713FM Radio Airplay"). The Service will include the cataloging, indexing, sharing, biographies, and streaming of Artists aka User Content.

This Agreement sets out the legally binding terms between you and www.713fm.org. This Agreement applies to all Users of the 713FM. If you choose to use the 713FM, you will be agreeing to abide by all of the terms and conditions of this Terms and Conditions of Use Agreement (the "Agreement"). www.713fm.org may change, add, or remove portions of this Agreement at any time, but if it does so, it will post such changes on the Platform www.713fm.org.

IF ANY OF THESE RULES OR ANY FUTURE CHANGES ARE UNACCEPTABLE TO YOU, DO NOT USE THE SERVICE. YOUR CONTINUED USE OF THE SERVICE NOW, OR FOLLOWING THE POSTING OF NOTICE OF ANY CHANGES IN THESE OPERATING RULES, WILL INDICATE ACCEPTANCE AND AGREEMENT BY YOU OF SUCH RULES, CHANGES, OR MODIFICATIONS.

- 3. The license you grant to 713FM is non-exclusive (meaning you are free to license your Content to anyone else in addition to 713FM), fully paid, and royalty-free (meaning that 713FM is not required to pay you or anyone else deriving rights from you for the use on the 713FM Free Use Platforms of the Content that you email, text, send or post to us), sublicensable (so that 713FM is able to use its affiliates, partners, subcontractors, Internet content delivery networks and wireless carriers to provide the 713FM Platforms), and worldwide (because the Internet and the 713FM Platforms are global in reach).
- 4. 713FM does not claim any ownership rights in your content. You will continue to own your content and can use it in any way that You choose 100%.

## **Privacy**

You must have the right to submit the material(s) to our Platform for our use. This also applies to ANRs, Managers, Keymans, Publicists, and Email Blast Services that the Artists/Companies/Labels, etc may use to submit their work/music to us "www.713fm.org...

By providing any material to us, you certify: that you own or control the publishing rights to the material; and that you are giving 713FM permission to put it up on our Platforms at www.713fm.org for online streaming, without restriction.

By uploading **Your Content** through our registration form, emailing us at info@713fm.org, scooppa@gmail.com, or painmuzikhtx@gmail.com, messaging us on our Instagram accounts @713fmhtx and @painmuzikstudio or texting us any of your info/music at +1 (713) 352-8729, You grant 713FM a *non-exclusive* license (including the right to sub-license for all purposes related to the 713FM service (such as, for example, embedding the 713FM radio player on third-party websites, social media sites or personal blogs) throughout the world to:

- (a) communicate and make Your Content available on the 713FM Radio Platforms, and
- (b) to copy and otherwise **Exploit Your Content** as necessary for all purposes associated with the **713FM Platforms**.

### You shall deliver to 713FM:

- (a) Copies of the master versions of Your Content from which 713FM shall be entitled to make copies for the purpose set out in this Agreement;
